

## ePay Online Payment System Set-Up and Use

In order to use this payment system, you must have:

1. Bankruptcy Case Number
2. Last four digits of your Social Security number
3. A Checking or Savings Account routing and account number, and
4. A valid current e- mail address.

### Register:

1. Go to the Trustee website: <http://ch13md.com>
2. Click on Make an Electronic Payment:

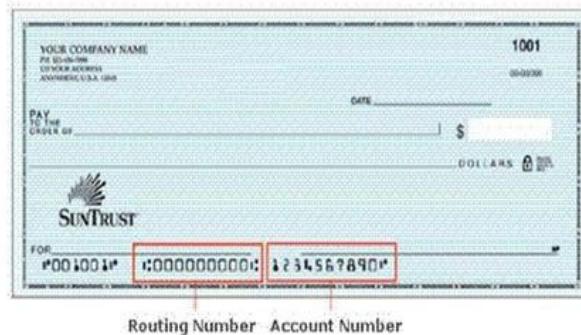
